# 1.0 Purpose

To define a policy for installation of window air conditioners that avoids exterior damage and maintenance problems and maintains a pleasing and consistent appearance of university buildings.

## 2.0 Policy

All window air conditioners in main campus buildings will be installed so that no portion of the unit extends past the outside wall of the building. This will normally require that a plenum be installed inside the room and that a condensate drain be run to either the building drain system or the outside of the building.

### 3.0 Procedures

Design and construction must be in accordance with <u>University Policy 5405</u>, <u>Non-capital Construction</u>, <u>Renovation</u>, <u>Maintenance and Repair of University-owned Facilities</u>), the <u>Virginia Tech, Design and Construction Standards</u>, and the <u>Virginia Tech Climate Action Commitment</u>.

## 4.0 Definitions

**Plenum** – part of a building, or pathway, that can facilitate air circulation.
